**ARTICLES OF INCORPORATION**

**OF**

**PATNICK'S, INC.**

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation,

**ARTICLE I. NAME**

The name of the corporation shall be PATNICK'S, INC.

**ARTICLE II. PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: 2665 North Forest Ridge Blvd., Hernando, FL 34442

**ARTICLE III. PURPOSE**

The purpose for which the corporation is organized is to transact all lawful business for which Corporations may be organized under the Florida Business Corporation Act.

**ARTICLE IV. CAPITAL STOCK**
