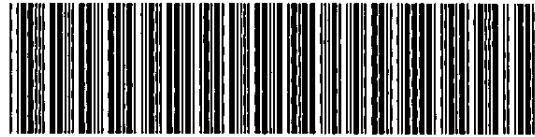

**RESOLVED FURTHER**, that ARTICLE III. CAPITAL STOCK is hereby revised in its entirety to read as follows:




**RESOLVED FURTHER**, that ARTICLE VI. INITIAL CAPITAL is hereby revised in its entirety to read as follows:
