

OF THE

WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation of such corporation.

ARTICLE I, NAME: The name of the corporation shall be: American Safe Driving Academy, Inc.

ARTICLE II, PRINCIPAL OFFICE: The initial principal place of business and mailing address of this corporation shall be: One Parlicu Place, Suite 242, Winter Park, FL 32792.

ARTICLE III, SHARES: The aggregate number of shares of stock that this corporation is authorized to issue is 1,000 shares of common stock having a value of \$1.00 (one dollar) per share.

ARTICLE IV, INITIAL REGISTERED AGENT AND STREET ADDRESS: The name and address of the initial registered agent is: Thomas S. Kornegay, 3122 T.C.U. Blvd., Orlando, FL 32817

ARTICLE VII, CUMULATIVE VOTING: Cumulative voting of shares of stock is not authorized.

ARTICLE VIII, ACCESS TO ADDITIONAL SHARES OF STOCK: There shall be no provisions limiting or denying shareholders the preemptive right to acquire additional or treasury shares of the corporation.




