Name and Mailing Address The name of this corporation is WHITE RABBIT ASSOCIATES, INC and its mailing address is Suite 101, 345 E Highway 436, Fern Park, FL 32730

ARTICLE II

Business and Activities This corporation may, and is authorized to, engage in any other activity or business permitted under the laws of the United States and of the State of Florida

ARTICLE III

Capital Stock The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares of common stock having a par value of \$1.00 per share, with the consideration to be paid for each share to be in money, property or services, as may be fixed by the Board of Directors

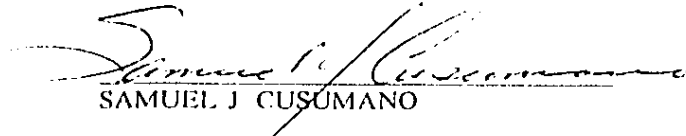
