ARTICLIS OF INCORPORATION

Indirect obligations of the United States or of any other government, state, territory, governmental district, or municipality or of any instrumentality thereof;

To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure say of its obligations by mortgage or piedge of all or any of its property, franchises, and income:

To lend money for its corporate practors, invest and reinvest its funds, and take and hold real and personal property as security of the payment of funds so leaned or invested:

To conduct its business, carry on its operations, and have offices and exercise the powers granted by this act within or without this state;
