# ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation.

# Article I

### Name

The name of the corporation is TLC YACHT MAINTENANCE CORPORATION.

# Duration
