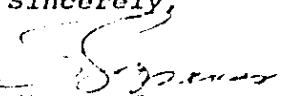

ARTICLES OF INCORPORATION

The undersigned incorporator hereby delivers these Articles of Incorporation in order to form a corporation under the Florida General Corporation Act.

ARTICLE I - NAME

The name of this corporation is Steven S. Graves, P.A. The address of the principal office and place of business of this corporation is 650 West Montrose Street, Suite B, Clermont, Florida 34711.

ARTICLE II - DURATION

The existence of this corporation shall commence on the date below that these Articles of Incorporation are signed. This corporation shall have perpetual existence unless dissolved in accordance with the laws of the State of Florida.

ARTICLE III - PURPOSE

This corporation exists to:

A. Engage in every phase and in every aspect of the business of rendering the same professional services to the public that an Attorney and Counselor at Law, duly licensed under the laws of the State of Florida, is authorized to render; but, such professional services shall be rendered only through individuals who are authorized by the laws of the State of Florida to render such professional services.

B. Invest the funds of the corporation in real estate,

mortgages, stocks, bonds, or any other type of investment, and to own real and personal property necessary to perform the tasks described in Paragraph A.

C. To do everything and anything necessary or incidental and proper for the accomplishment of any of the purposes enumerated in this Certificate of Incorporation or any Amendment thereof, or for the attaining of any of the objects for the furtherance of any of the purposes, or for the protection and benefit of the corporation.

The foregoing paragraphs shall be construed as enumerating the objects, purposes, and powers of the corporation. It is expressly provided that the foregoing enumerations of specific powers shall not be held in any manner to limit or restrict the powers of the corporation otherwise permitted by law.

#### ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one thousand (1,000) shares of One Dollar (\$1.00) par value common stock.

#### ARTICLE V - INITIAL REGISTERED AGENT AND OFFICE

The initial registered agent of this corporation is Steven Scott Graves. The Street address of the initial registered agent of this corporation is 650 West Montrose Street, Suite B, Clermont, Florida 34711.

#### ARTICLE VI - BOARD OF DIRECTORS

This corporation shall initially have one (1) director. The number of directors may be increased or decreased from time to time by the by-laws, but shall never be less than one (1) nor more than the

number of registered stockholders.


**ARTICLE VII - INCORPORATOR, DIRECTOR, SHAREHOLDER, SUBSCRIBER**

**ARTICLE VIII - STOCK REGISTRATION**

The directors of this corporation are authorized to adopt by-laws restraining the transfer and alienation of stock of this corporation, to provide for the purchase or redemption by this corporation of its shares and to establish a method of determining a price at which shares may be purchased or redeemed.
