

ARTICLES OF INCORPORATION
OF
GENERAL SITE CONTRACTORS, INC.

The undersigned incorporators hereby form a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be:

GENERAL SITE CONTRACTORS, INC.

ARTICLE II - NATURE OF BUSINESS

The nature of business for which this corporation is organized is to engage in any activity of business permitted under the laws of the United States and of the State of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 100 shares of no par value common stock.

ARTICLE IV - REGISTERED OFFICE ADDRESS

The street address of the initial principal office of the corporation shall be 3412 Rider Place, Orlando, Florida 32817; and the name of the initial registered agent of the corporation is Robert B. Worman, Esquire, at 105 East Robinson Street, Suite 540, Orlando, Florida 32801.

ARTICLE V - TERM OF EXISTENCE

This corporation is to exist perpetually.
