NAME

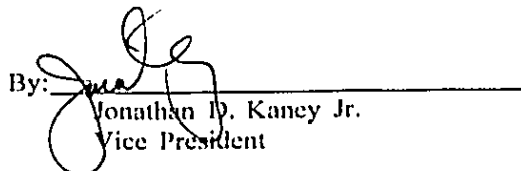
