CERTIFICATION OF INCORPORATION OF NEWRICK ENTERPRISES -INC

We, the undersigned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the provisions of an Act of the beginsature of the State of Florida approved dune 1, 1925, and the acts amendatory thereto, do hereby subscribe to this Certificate of Incorporation.

The name of the Corporation is: NEWRICK ENTERPRISES INC FIRST:

The general nature of business to be transacted by the Corporation is as follows:

Building construction, painting, pantry and waterproofing, general labor, electrical, plumbing, trash and garbage cleaning, site cleaning; disposal and hauling, debre removal, landscaping and maintenance, general carpentry, Installing drapes, tile, carpet, b linds, rugs, acoustical ceiling fans, molding, janitorial service, security services, guards, armed and unarmed, security devices. To manufacture, purchase, or otherwise acquire, and to own and mortgage, pledge, sell, assign and transfer or otherwise dispose of, and to invent, trade, deal in and with goods, wares, merchandise and other personal and real property of every class and description whatsoever.

To buy, sell, manufacture, repair, alter and exchange, let or hire, export and deal in all kinds of articles and things which may be required for the purposes of any of the said business or commonly supplied or dealt in by persons engaged in any such business, or which may be capable of being profitable dealt with in connection with any of the said business.
