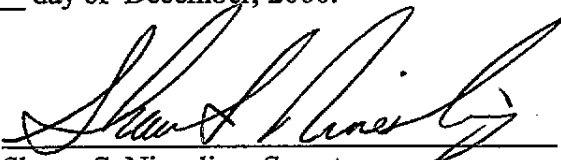
1. Article I is deleted in its entirety and the following substituted in lieu thereof:
