ARTICLES OF INCOMPORATION oF THE OUTLET MALL, INC

Atticle I Name & Address

The name and address of this corporation is THE OUTLET MALL, INC. and The address is 6409 Parkland Drive, Sarasota, Florida 34243.

Article [I - Term

This corporation shall commence to exist as of July 31, 1995, and shall exist perpetually or until legally dissolved.

Article III - Purpose

This corporation is organized for the purpose of direct marketing and any other lawful business and doing all acts necessary or convenient to carry on the business of the corporation or to effect or promote the purposes for which the corporation is formed.

Article IV - Capital Stock

This corporation is authorized to issue three million (3,000,000) shares of par value of FOUR DOLLARS (\$4.00) per share common stock.
