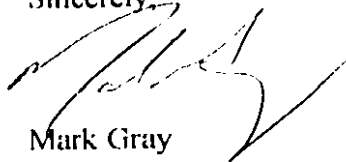

ARTICLES OF INCORPORATION  
OF  
THE MALL ASSOCIATES, INC  
Article I - Name & Address

The name and address of this corporation is THE MALL ASSOCIATES, INC and the address is 6489 Parkland Drive, Sarasota, Florida 34243.

Article II - Term

This corporation shall commence to exist as of July 31, 1995, and shall exist perpetually or until legally dissolved.

Article III - Purpose

This corporation is organized for the purpose of real and intangible property acquisition and leasing and any other lawful business and doing all acts necessary or convenient to carry on the business of the corporation or to effect or promote the purposes for which the corporation is formed.

Article IV - Capital Stock

percent (10%) of the shares entitled to vote on the subject matter shall be the act of the corporation.

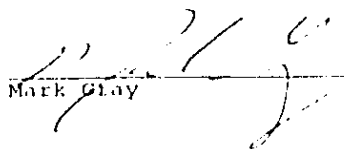
Article VII Incorporator
