The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, and duly licensed to render services under the laws of the State of Florida, hereby presents these Articles for the formation of a coporation under the laws of the State of Florida.

ARTICLE I.

NAME.

The name of this corporation is

NATURE OF BUSINESS.

The Corporation may engage in every phase and aspect of the business of rendering the same professional services to the public that a certified public accountant, duly licensed under the laws of the State of Florida, is authorized to render.

ARTICLE III.

CAPITAL STOCK.

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ONE HUNDRED (100) -- shares of common stock having a One Dollar (\$1.00) par value.
