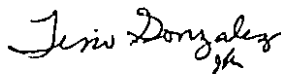

ARTICLE I - CORPORATE NAME

The name of this corporation is THE COUNTY LINE OF BREVARD, INC., whose principal office and mailing address is 3135 Shady Dell Lane, #216, Melbourne, Florida 32935.

ARTICLE II - NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

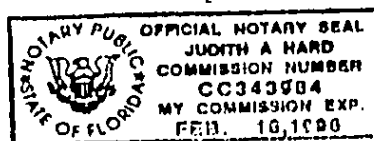

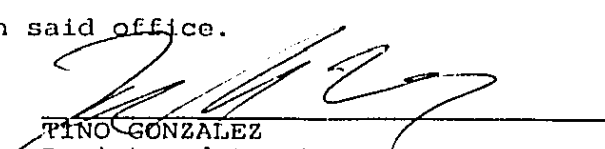
