ARTICLES OF INCORPORATION OF FIRE/RESCUEINTERNATIONAL RESEARCH ENTERPRISES, INC.

The undersigned, acting as incorporator of a corporation to be formed under the provisions of the laws of the State of Florida, hereby adopts the following Articles of Incorporation for such corporation, to be filed with the Secretary of State of the State of Florida:

ARTICLEJ

The name of the corporation shall be FIRE/RESCUE INTERNATIONAL RESEARCH ENTERPRISES, INC.. The principal place of business of this corporation shall be 420 S.W. 18th Terr., Miami, FL 33129-1021.
