The undersigned, acting as the incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such a corporation:

**ARTICLE I**

NAME: The name of the Corporation is: TOMARI FOODS, INC.

**ARTICLE II**
