

# ARTICIA I

The name of this Corporation is D-JAG, INC.

### ARTICLE II

The term of existence of the Corporation is perpetual, unloss sooner dissolved according to law; and the Corporation's existence shall commands upon the filing of these Articles of Incorporation with the Department of State, State of Florida.

permitted by Section 607.0732 of the Florida Statutes.

Any action required or permitted to be taken by the officer/ shareholder(s) under any provision of law shall bind the Corporation.

#### ARTICLE V

The Corporation may indomnify and hold any and all officers: barmless to the full extent permitted by law.

#### ARTICLE VI
