ARTICLES OF INCORPORATION OF

WONG AND YUNG INC.

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE: WONG AND YUNG INC.

ARTICLE II

THE CORPORATION WILL ENGAGE IN ANY ACTIVITY PERMITTED BY THE LAWS OF THE STATE OF FLORIDA AND THE UNITED STATES OF AMERICA.

ARTICLE III

THERE SHALL BE AUTHORIZED FIVE HUNDRED SHARES OF COMMON STOCK AT A PAR VALUE OF ONE DOLLAR.
