The undersigned for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation.

ARTICLE ONE

The name of the corporation is No Excuse Skin and Nail Care, Inc.

CORPORATE DURATION

The duration of the corporation is perpetual.

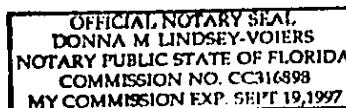
