ARTICLES OF INCORPORATION

I, the undersigned, being a natural person of legal age do hereby desire to form a corporation under the laws of the state of Florida, and do hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be MOR 4-U, INC., a Florida corporation. The principal place of business of this corporation shall be 155 Barclay Court, DeBary, Florida.

ARTICLE II

GENERAL NATURE OF BUSINESS

This corporation shall have those powers authorized or permitted by law or otherwise, it being the intention that this corporation shall have the right to engage in any business or activity not expressly prohibited by applicable law of the state of Florida.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock of this corporation which the corporation is authorized to have outstanding at any one time is 500 shares of common capital stock having a par value of \$1.00 per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors of this corporation.

INITIAL BOARD OF DIRECTORS

##### INDEMNIFICATION



The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such director, officer, employee or agent may be entitled.

The corporation reserves the right to amend, alter, change, repeal and revise any of the provisions of this corporation's Articles of Incorporation in the manner now, or hereafter proscribed by statute and all rights conferred on shareholders herein are granted subject to this reservation.




