ARTICLES OF INCORPORATION  
OF  
CIRCLE SEVEN-L, INC.

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is CIRCLE SEVEN-L, INC., and the street address of its principal office is 11712 N.W. 69th Terrace, Alachua, FL 32615 and its mailing address is 174 Turkey Creek, Alachua, FL 32615.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on the date of subscription and acknowledgment of the Articles of Incorporation.

ARTICLE III

General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

ARTICLE IV

Capital Stock

The aggregate number of shares of stock authorized to be issued by this corporation shall be ten thousand (10,000) shares of common stock, each with \$1.00 par value.
