ARTICLES OF INCORPORATION  
OF  
SANTRAM, INC.

KNOW ALL MEN BY THESE PRESENTS: That the undersigned incorporator hereby certifies that he has formed a body corporate under and by virtue of the laws of the State of Florida for the transaction of business with and under the following charter:

Article I - Name

The name of the corporation shall be SANTRAM, INC., with its principal office located at 4700 Dixie Highway NE, Palm Bay, Florida 32905. The mailing address is 8507 Pajaro Court, Orlando, Florida 32836.

Article II - Duration

The corporation shall have perpetual existence, unless terminated in the manner prescribed by the laws of the State of Florida.

Article III - Purpose

The purpose for which the corporation is formed is to engage in any lawful activity or business.

Article IV - Capital Stock

This corporation is authorized to issue 1,000 shares of one dollar (\$1.00) par value voting common stock. Said stock shall be issued only as and when and for such consideration as determined by the incorporator or stockholders.

Article V - Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 4700 Dixie Highway, NE, Palm Bay, Florida 32905, and the name of the initial registered agent of this corporation at that address is BHIKHABHAI L. PATEL.

Article VI - Incorporator

The name and address of the person signing these Articles is: BHIKHABHAI L. PATEL, 8507 Pajaro Court, Orlando, Florida 32836.

Article VII - Management by Stockholders

The business of the corporation shall be managed, controlled and conducted by the Stockholders of the corporation, as shall be provided for in the by-laws from time to time, and such other officers, if any, as shall be provided for in the by-laws from time to time; provided, however, that as long as the business of the corporation is managed, controlled and conducted by the Stockholders of the corporation, then:

A. Wherever the context requires, the Stockholders of the corporation shall be deemed directors of the corporation for purposes of applying the provisions of Florida Statutes.

B. The Stockholders of the corporation shall be subject to the liabilities imposed by Florida Statutes for action taken by Directors.

C. Any action required or permitted by Florida Statutes to be taken by the directors of the corporation may be taken by

action of the Stockholders of the corporation at a meeting of the Stockholders or as hereinafter provided.

The Stockholders shall have the power to fix the amount of all salaries and other compensation paid by the corporation, including their own salaries as Directors, Officers or otherwise.

The Stockholders shall have the power to adopt, amend and repeal by-laws not consistent with law or the Articles of Incorporation of the company; provided, however, that the Stockholders shall be subject to the power of the holders of the outstanding stock of the company to change or repeal such by-laws or any of them.

The first annual meeting of the Stockholders shall be held at such time and place as may be designated in the by-laws of the corporation.

Management by Stockholders. If the business of the corporation is managed, controlled and conducted by the Stockholders, then any action of the Stockholders of the corporation may be taken without a meeting if consent in writing, setting forth the action so taken, shall be signed by a majority of the persons who would be entitled to vote upon such action at a meeting and filed as a part of the corporate records. Such consent shall have the same force and effect as a vote of the Stockholders.

#### Article VIII - Corporate Powers

This corporation shall have all powers granted to corporations by Florida Statutes unless otherwise provided in the by-laws of the corporation.

Article IX - Stockholders Not Personally Liable  
for Corporate Debts

The private property of the Stockholders shall not be liable for the payment of debts of the corporation to any extent whatsoever except for the balance unpaid on any of their stock subscriptions.

Article X - Amendment

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, any right conferred upon the shareholders is subject to this reservation.

Article XI - Effective Date

The corporation's existence shall begin on July 28, 1995.

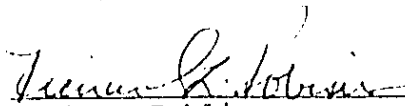
