OF

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. The name of the corporation is HEADLINES HAIR STUDIO, INC. Its principal place of business is at 3452 West Boynton Beach Boulevard, Suite 5, Plaza West, Boynton Beach, Florida. 33434.

2. The period of its duration is perpetual.

3. The purpose of the corporation is to engage in any activities or business permitted under the laws of the United States of America, the State of Florida and any other country or state in which it may from time to time have occasion to do business. In particular, the purpose of the corporation is to provide hair styling to individuals as the law may permit.

4. The corporation shall have authority to issue 1000 shares of common stock, all of one class, which shall have a par value of \$1.00 per share.

5. The address of the corporation's initial registered agent is 4404 Nicia Way, Greenacres, Florida 33463, and the name of its initial registered agent at said address is George Cervasio.

6. The number of directors constituting the initial Board of Directors of the corporation is two (2), whose names and addresses are:
