**ARTICLES OF INCORPORATION
OF
ROYAL RV RESORTS, INC.**

The undersigned, acting as incorporator of this corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be **ROYAL RV RESORTS, INC.**

ARTICLE II - TERM OF EXISTENCE

Existence of this corporation shall exist perpetually.

ARTICLE III - GENERAL PURPOSE

The general purpose for which this corporation is organized shall be:

1. To manufacture, construct, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with products, goods, wares, merchandise, real and personal property and services of every kind, class, and description.

2. To operate a recreational vehicle park.

3. It is intended that this corporation is organized for and may conduct and transact any or all lawful business authorized and not prohibited by Chapter 607, Florida Statutes as the same may be from time to time amended; provided, however, and notwithstanding the generality of the foregoing, this corporation is not to conduct a banking, safe deposit,

trust, insurance, surety, express, building and loan association, fraternal benefit society, state fair or exposition business.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of capital stock which this corporation is authorized to issue and have outstanding at any one time is TEN THOUSAND (10,000) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.

ARTICLE V - REGISTERED OFFICE, REGISTERED AGENT, AND PRINCIPAL OFFICE

The initial street address of the registered office of this corporation in the State of Florida will be 102 E. Maple Street, Winter Garden, Florida 34787. The Board of Directors may from time to time move the registered office to any other address in Florida. The name of the initial registered agent of this corporation at that address is ERIC S. MASHBURN. The Board of Directors may from time to time designate a new registered agent. The principal office and mailing address for the corporation will be Post Office Box 770337, Winter Garden, FL 34777-0337.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

1. The initial number of Directors of this corporation shall be one (1).
2. The number of Directors may be increased or diminished from time to time by By-Laws adopted by the shareholders, but shall never be less than one.
3. The name and address of the initial member of the Board of Directors, who shall hold office for the first year of existence of this corporation or until her successor

is elected or appointed and has qualified, is:

ARTICLE VII

The name and address of the incorporator of this corporation is ERIC S. MASHBURN, ESQUIRE, P. O. Box 771277, Winter Garden, FL 34777-1277.

ARTICLE VIII - AMENDMENT TO ARTICLES

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders of the corporation is subject to this reservation.

ARTICLE IX

The corporation shall indemnify any registered agent, officer, director or incorporator, or any former registered agent, officer or director, to the full extent permitted by law.

ARTICLE X

Every shareholder of voting stock shall have the preemptive right to purchase his or her share of the issuance of any class of stock, including treasury stock, at the price offered in proportion to his or her holdings of stock.




