**ARTICLES OF INCORPORATION
OF
H & A CLEANING SERVICE, INC.**

TO: FLORIDA DEPARTMENT OF STATE

THE UNDERSIGNED ACTING AS INCORPORATOR OF A CORPORATION UNDER THE BUSINESS CORPORATION LAW OF THE STATE OF FLORIDA, ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION FOR SUCH CORPORATION:

**ARTICLE I
NAME OF CORPORATION**
