I, the undersigned natural person of the age of twenty-one years or more, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by the virtue of the laws of the State of Florida;

I.

The name of the corporation is A-1 Discount Towing & Transport, Inc.. whose principal office is located at 997 S.W. 33rd Street, Palm city, Martin County, FL. 34990.

II.

The peiod of duration of the corporation is perpetual.

III.

The purposes for which the corporation is organized are; the towing, purchase, repair, and wholesale of automobiles, trucks, and other vehicles in accordance with State of Florida regulations regarding such acts; and any other act or activities for which corporations may be organized under the General Statutes of the State of Florida.

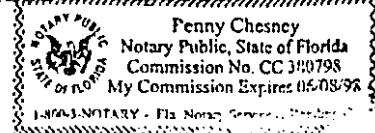
