As a follow-up to our telephone conference of January 24, 1997, enclosed herewith you will find an Application for Reinstatement for the above referenced corporation. This corporation showed to be administratively dissolved on August 23, 1996 for failure to file an annual report.

As we discussed, I had requested on behalf of my client a waiver of the current reinstatement fee and please accept this letter as a formal representation that my client never received the annual report form or reminder letters. Furthermore, my client was not aware of the need to file an annual report. It is apparent to us that there has been some problems with the forwarding of mail. My client's former landlord did, in fact, sell the building in which my client's place of business was located.
