

ARTICLES OF INCORPORATION
OF
INSTA MAIL, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation

ARTICLE I - NAME

The name of the corporation is INSTA MAIL, INC.

ARTICLE II - PRINCIPAL OFFICE

The purpose for which the corporation is organized is to engage in ADVERTISING AND MAILING SERVICE or business permitted under the laws of the United States and the State of Florida.


ARTICLE VIII - POWERS OF THE CORPORATION

The pre-emptive right of any holder is determined by the ratio of the authorized share of common stock held by the holder to all shares of common stock currently authorized.
