ARTICLES OF INCORPORATION
OF
INLINE INNOVATIONS, INC.

I, the undersigned, make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a professional service corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is INLINE INNOVATIONS, INC.

ARTICLE II - PRINCIPLE OFFICE

The principle office of the corporation is 380 S. State Road 434, Suite 1004-273, Altamonte Springs, FL 32714.

ARTICLE III - BUSINESS, OBJECTS OR PURPOSES

The general nature of the business to be transacted by this corporation or the objects or purposes of the corporation shall be as follows:

- (a) To provide marketing communications services to help companies develop quality, lead-generating marketing materials and comprehensive programs.
- (b) In general, to have and exercise all powers conferred by the laws of Florida upon professional corporations, and to do any and all things hereinabove set forth to the same extent as a natural person might or could do.
