**ARTICLES OF INCORPORATION  
OF  
PROGRESSIVE CASEWORK AND DISPLAYS, INC.**

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I - NAME OF CORPORATION**

The name of the corporation shall be Progressive Casework and Displays, Inc.

**ARTICLE II - PRINCIPLE OFFICE**

The principal office and mailing address for the corporation is at 289 Evansdale Rd., Lake Mary, FL 32746.

**ARTICLE III - TERM OF EXISTENCE**

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.

**ARTICLE IV - PURPOSES**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE V - CAPITAL STOCK**

The corporation is authorized to issue and have outstanding one thousand (1,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

**ARTICLE VI - PREEMPTIVE RIGHTS**

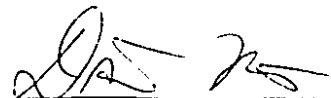
#### ARTICLE X - AMENDMENT TO ARTICLES

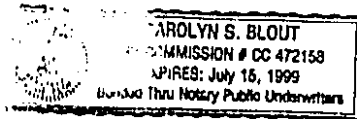
