ARTICLES OF INCORPORATION

OF

UNITED SCREEN ENCLOSURES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I -- NAME

The name of the corporation shall be UNITED SCREEN ENCLOSURES, INC.

ARTICLE II -- NATURE OF BUSINESS

1. The general nature of the business of the corporation shall be screen enclosures.

2. This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.
