ARTICLE I - NAME

The name of this Corporation is MacOutlet, Inc. and the address is 2204 N. Citrus Boulevard, Suite 2, Leesburg, Florida 34748.

ARTICLE II - TERM OF EXISTENCE

This Corporation shall exist perpetually.

ARTICLE III - NATURE OF BUSINESS

This Corporation may engage or transact in any or all activities or businesses permitted in the laws of the United States of America and the State of Florida.

ARTICLE IV - CAPITAL STOCK

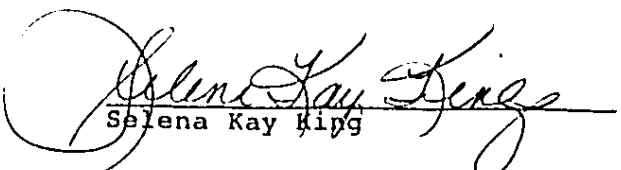

of the outstanding shares entitled to vote.

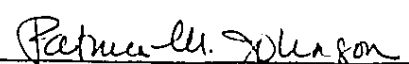

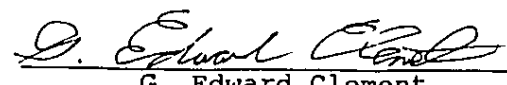
