The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

EFFECTIVE DATE

ARTICLE I - NAME OF CORPORATION

7-24-95

The name of this corporation shall be ORION HOME BUILDERS, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 744 Highland Avenue, Orlando, Florida 32803

ARTICLE III - DURATION

This corporation shall exist perpetually, commencing as of the date of execution of these Articles of Incorporation.

ARTICLE IV - PURPOSE

The general purposes for which the corporation is organized are:
