ARTICLES OF INCORPORATION

OF

HAROLD'S A/C & REFRIGERATION SERVICE , INC.

We, the undersigned subscribers to these Articles of Incorporation, natural persons, competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is: HAROLD'S A/C & REFRIGERATION SERVICE, INC.

ARTICLE II

The general purposes for which the corporation is organized are:

- 1 To engage in all aspects of the air conditioning and refrigeration sales and service.
- 2 To transact any business for which corporations may be incorporated under the Florida General Corporation Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE III
