## ARTICLES OF INCORPORATION

MR. SCIENCE, INC.

### ARTICLE I - NAME

The name of the corporation is MR. SCIENCE, INC., with a mailing address of 400 Lake View Dr., S. Melbourne Beach, Fla. 32951.

### ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of the State of Florida.

### ARTICLE III - PURPOSE

This corporation is organized for the purpose of engaging in the rental, sales, etc. of scientific and educational dissemination and other legal and lawful act or activity for which corporations may be organized under the laws of the State of Florida.

### ARTICLE IV - CAPITAL STOCK






