ARTICLE I

The name of this corporation is. AERO PARTS SUPPORT U.S Inc.

ARTICLE X - INCORPORATOR

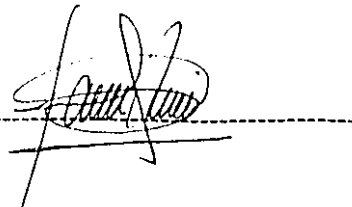
