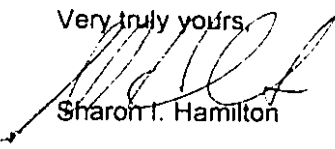

ARTICLES OF INCORPORATION
OF

The undersigned Incorporators to these Articles of Incorporation, hereby form a Corporation for the business of a limousine service pursuant to the regulations set forth in the Florida Statute governing corporations.

ARTICLE I
CORPORATE NAME

The name of this Corporation is: FLAMINGO ISLE CONSULTING, INC. with its principal place of business at 697 Copa d' Oro Marathon, Florida, 33050.

ARTICLE II
PURPOSES

The purposes for which this Corporation is organized is as follows:

To engage in the specific business of computer software sales and to operate and own any other business that may be acquired by Flamingo Isle Consulting, Inc.

ARTICLE III
CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is TWENTY (20) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share. Shares may be issued only for a consideration having a value, in the judgment of the Board of Directors, at least equivalent to the full par value of the stock to be issued. All shares issued shall be fully paid and nonassessable.

ARTICLE IV
TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE V
BOARD OF DIRECTORS

This Corporation shall have two directors initially. The number of directors may be increased from time to time by the By-Laws adopted by the stockholders, but shall never be less than one.

ARTICLE VI
INITIAL DIRECTORS

No contract between this corporation and another corporation or another individual shall be invalidated by reason of the fact that one or more of the officers or directors of this corporation are officers or directors of the said other corporation, or by reason of the fact that one or more of the officers or directors of this corporation may be the other individual or individuals contracting with this corporation.

ARTICLE IX
AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholder's meetings by at least a majority of the stock entitled to vote thereon, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment to these Articles of Incorporation be made.

REGISTERED AGENT AND INITIAL REGISTERED OFFICE

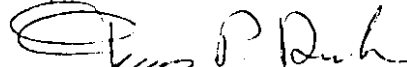
