ARTICLES OF INCORPORATION OF NATIONAL CONSTRUCTION SERVICES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation

# ARTICLE I - NAME

The name of the corporation is NATIONAL CONSTRUCTION SERVICES, INC.

ARTICLE II - PRINCIPAL OFFICE
