## INDEMNIFICATION

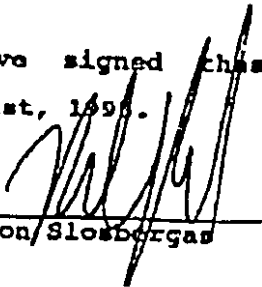

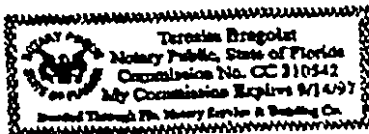

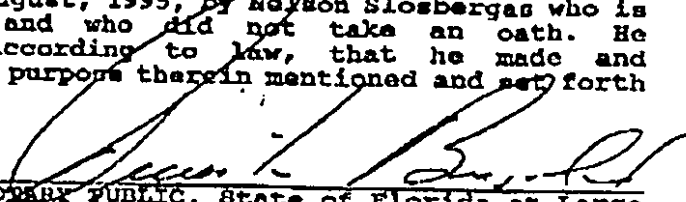
