ARTICLES OF INCORPORATION

OF

EMERALD INSURANCE SERVICES OF BRADENTON, I...C.

The undersigned subscriber(s) to these Articles of Incorporation, being natural person(s) competent to contract, hereby, for the purpose of forming a corporation under the laws of the State of Florida, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME The name of the corporation shall be EMERALD INSURANCE SERVICES OF BRADENTON, INC.

ARTICLE II

NATURE OF BUSINESS The general nature of the business to be transacted by this corporation is:

- 1. To corduct business in, having one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real property and personal property, including tranchises, patents, copyrights, trademarks, and licenses in the State of Florida and all other states and countries.
- To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes, and other evidences of indebtedness, and execute such mortgages, or transfers of corporate indebtedness as required.
- 3. To purchase the corporate assets of any other corporation engaged in same or other character of business.
- 4. ARTICLE III

<u>CAPITAL STOCK</u> The maximum number of shares of stock this corporation is authorized to have outstanding at any time is 7,000 shares of common stock at a par value of One Dollar (\$1.00) per share.

ARTICLE IV

INITIAL CAPITAL The amount of capital with which this corporation will begin business is Five Hundred Dollars (\$500.00).

ARTICLE V

TERM OF EXISTENCE The corporation is to exist perpetually.

ARTICLE VI

ADDRESS The initial address of the principal offices of the corporation is 3633 Cortez Road, #A08, Bradenton, FL, 34210. The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

ARTICLE VII

<u>DIRECTORS</u> The corporation shall have two (2) Directors initially. ARTICLE XI

<u>PRE-EMPTIVE RIGHTS</u> Each shareholder of this corporation shall have a preemptive right to purchase additional shares of the corporation at any such time as the same are offered for sale by the corporation.
