The undersigned, acting as incorporators of a corporation under the Florida Statutes, adopts the following Articles of Incorporation:

First: The name of the corporation is:

Third: The period of its duration is perpetual unless sooner dissolved.

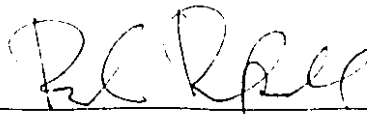

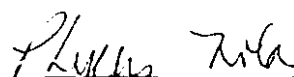
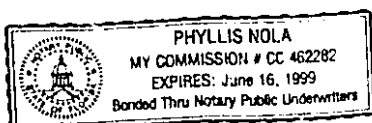
