Dear Madam,

I was recently informed that I.N. Fashion, Inc. had been dissolved because I had not filed the 2001 Annual Uniform Business Report, and a fee of \$400 would be charged to re-instate the corporation.

However, I had sent in the completed report with a check for \$150 before the deadline. I received a letter from you in June stating that the business form I had submitted was incomplete and could not be accepted (letter number: 501A00034996). I was given a period of a month to re-file the completed report to avoid any penalty. The report was re-filed within that period accompanied by a check for \$150. I did not receive any further notices, which led me to believe that the report had been correctly filed. Recently however, I received the notice informing me of the dissolution of the corporation.

As you know, because of the terrible events of September 11th, the last few months have been dismal ones for businesses, especially small single-owner businesses like mine. I simply do not know how I could accomodate additional and unforeseen expenses. I would request you, therefore, to please waive this penalty, which I feel is through no fault of mine, and re-instate my corporation, I.N. Fashion, Inc. I do hope you will consider this request.
