ARTICLES OF INCORPORATION

OF

WALLCOVERING DESIGNS, INC.

The undersigned, being an individual, does hereby act as the incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The name of the corporation (hereinafter referred to as the "corporation") is WALLCOVERING DESIGNS, INC.

SECOND: The street address, wherever located, of the principal office of the corporation is 1583 North Military Trail, West Palm Beach, Florida 33409.

The mailing address, wherever located, of the corporation is the same as above.

THIRD: The number of shares which the corporation is authorized to issue is One Thousand (1000), all of which are of one class and are Common shares with a par value of \$.01 per share.

FOURTH: The street address of the initial registered office of the corporation in the State of Florida is 1583 North Military Trail, West Palm Beach, Florida 33409.

SIXTH: The corporation is for profit.

SEVENTH: The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the Florida Business Corporation Act.

EIGHTH: The corporation shall, to the fullest extent permitted by the provisions of the Florida Business Corporation Act, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said provisions from and against any and all of the expenses, liabilities, or other matters referred to or covered by said

provisions, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, vote of shareholders or disinterested directors, or otherwise, both as to action in his or her official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person.

NINTH: Whenever the corporation shall be engaged in the business of exploiting natural resources or other wasting assets, distributions may be paid in cash out of depletion or similar reserves at the discretion of the Board of Directors and in conformity with the provisions of the Florida Business Corporation Act.

TENTH: The period of duration of the corporation is perpetual.

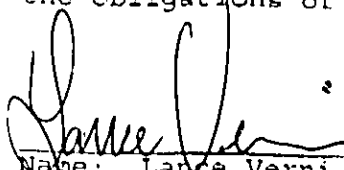
