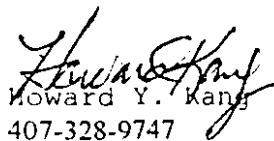

ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming corporation under the Florida General Corporation Act hereby adopt the following articles of incorporation:

EFFECTIVE DATE

ARTICLE ONE

NAME

The name of the corporation is Oak Hill Golf Course, Inc..

ARTICLE TWO

DURATION

This corporation shall commence existence as of the date of execution of these Articles. The term of existence shall be perpetual.

ARTICLE THREE

PURPOSE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE FOUR

CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is 2500 shares, all of which shall be common shares with par value of \$1.00 per share.

ARTICLE FIVE

PREEMPTIVE RIGHTS GRANTED

Each shareholder of any class of stock of this corporation shall be entitled to full preemptive rights to purchase his prorata share of any unissued or treasury

shares of the corporation of the same kind, class or series as that which he already holds, and any securities of the corporation convertible into or carrying a right to subscribe to acquire shares of any such unissued or treasury shares at the price at which it is offered to others (without the issuance of fractional shares).

#### ARTICLE SIX

##### RESTRICTION ON TRANSFER OF STOCK

Shares held by the initial shareholders may not be resold or otherwise transferred to other persons unless such shares are first offered to the remaining shareholders or to this corporation. The price and terms at which, and the time within which such shares may be offered and resold shall be determined by an affirmative vote of 3/4 of the outstanding shares of this corporation.

#### ARTICLE SEVEN

##### REGISTERED OFFICE

The address of the initial registered office of the corporation is 348 North US 1, Oak Hill, Florida 32759; and the name of the initial registered agent at such address is Howard Y. Kang.

#### ARTICLE EIGHT

##### INITIAL STOCK SUBSCRIPTIONS

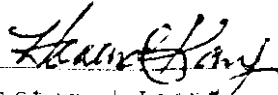
