ARTICLES OF INCORPORATION  
OF  
NATIONAL HEALTHCARE ALLIANCE MANAGED CARE, INC.

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is National HealthCare Alliance Managed Care, Inc., and its principal office and mailing address are 100 Galleria Parkway, Suite 400, Atlanta, Georgia, 30339.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on August 2, 1995.

General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.
