#### ARTICLE I

The name of this Corporation shall be DOLPHIN TRANSPORTATION, INC.

# ARTICLE II

This Corporation shall exist in perpetuity.

#### ARTICLE III

The general nature of the business to be transacted by this Corporation is to: Kanufacture, purchase or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, foodstuffs, and services of every kind and description, except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telephone, telegraph, or cemetery company, a building and loan association, fraternal benefit society, state fair or exposition.

#### ARTICLE IV

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is One Thousand (1,000) shares of common stock having a par value of One Dollars (\$1.00) per share.
