Dear Reviewer:


I called your office for reinstatement and spoke with a representative today. The annual fee for my 1996 Corporation Annual Report was not paid and the status has lapsed. I incorporated this business 8/7/95 and have not yet begun to do business. Pursuit of it was set aside by family problems.

I have been in the middle of a very messy divorce for the last year and a half, and my mail was not forwarded. Such was the case with the Annual Report form for 1996. I never received it. And, since I had never actually done any business through this corporation, I really didn't know to look for or expect the form.

I am now divorced, living at a permanent address (above) and in an effort to make a living and get on with my life at 50, I need some consideration from your office. The Corporate Annual Return was not filed, but not through intentional disregard. And now, to reinstate at full price would be prohibitive. I need to earn a living and am now preparing to get a small service business started.

I am enclosing a check for \$365.00 (\$ 200 for 1996 and \$ 165 for 1997). Even these amounts represent a serious effort as I have not yet earned any money from the Corporation. I would appreciate your consideration in accepting these fees as payment in full. Those of us starting out on our own in mid-life could use a helping hand from the bureaucracy, especially when we are intent on working for a living and not showing up in the lines of unemployed, etc. Thank you.
