ARTICLES OF INCORPORATION

OF

OrNda FMC, Inc.

ARTICLE I - NAME

The name of the corporation is OrNda FMC, Inc. (hereinafter called the "Corporation").

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under The Florida Business Corporation Act of the State of Florida.

ARTICLE III - CAPITAL STOCK
