Articles of Amendment to Articles of Incorporation
of Wotitzky, Wotitzky, Ross & Goldman, P.A.

THESE ARTICLES OF AMENDMENT are hereby made to the Articles of Incorporation of WOTITZKY, WOTITZKY, ROSS & GOLDMAN, P.A., a corporation organized under and pursuant to the provisions of Chapter 607 and 621 of the Florida Statutes. Pursuant to Section 607.1006 of the Florida Statutes, the following Articles of Amendment to the Articles of Incorporation of this corporation are hereby made:

1. Article I of the Articles of Incorporation is amended to change the name of the corporation to Wotitzky, Wotitzky, Ross, Goldman, Sturges & Tuttle, P.A. Article I shall henceforth read as follows:

Article I

The name of this corporation shall be Wotitzky, Wotitzky, Ross, Goldman, Sturges & Tuttle, P.A. The physical business address, the mailing address, as well as the principal office of the corporation shall be 223 Taylor Street, Punta Gorda, Florida 33950.

2. The foregoing Amendment was adopted on August 30, 2002, and shall be effective on September 1, 2002.
3. The foregoing Amendment was approved by the shareholders. The number of votes cast for the Amendment was sufficient for approval.
